#### Citizen Input -

Marc Condensa, 6536 Terrace Dr., The Colony – He moved here from Frisco in May because of the park system. His kids use the trail. He runs on the shoreline trail and loves it. The city is a version of Lake Tahoe for him.

Greg Tonian, 6500 Stewart Blvd., The Colony – He is a resident since 2001. It's great that you can access the lake and nature from anywhere in the city whether you're jogging, walking or riding a bike. Continue to expand the trail system and enhance the natural beauty along the trail. Keep expanding the trails; he is excited about the trail linkages on the south side crossing HWY 121 and getting to Austin Ranch.

Joel Ortega, 5721 Trego, The Colony — He grew up in The Colony. He's a disc golfer and spends a lot of time on the disc golf course but is concerned about the erosion at Bill Allen Memorial Park. The focus should be on beautification, vegetation, adding native grasses, and to make sure Taylor drainage area is not forgotten in the process. He later added that Paige & South Colony would be a good place for new local businesses.

Shah Shahanawaz, 1515 Saintsbury, The Colony — He is a member of a local cricket organization that started 15 years ago. Cricket is the second most popular sport after soccer. He wants the city to adopt the sport and have cricket facilities here.

Tim Eorgan, 3833 Acacia Trail, The Colony – He is a member of The Colony RoadRunners. He enjoys running on the shoreline trail and riding his bike. Runners and bikers look for mileage; runners like to run 13-15 miles and bike riders like to ride 35-40 miles. He would like to see a trail connection to Grandscape.

Kristine Tague, 7133 Northpointe, The Colony – She has lived in The Colony for 6 years, has a newborn and 3-year old, and uses Bill Allen Memorial Park every day. The splash pad at the Aquatic Park is really bad so she goes to Carrollton to use their splash pad. She would like to see more parks for small kids, shade and water in the parks for cooling, and more native plants. She would like to see more opportunities for younger people to meet and wants to join teams as an individual.

Nathan Freystaetter, 5644 Powers, The Colony – He loves the outdoors; he rides a bike, runs and plays sports. Wants to see the city attract more small businesses. Would like to see more opportunities for younger adults to connect. He wants to know why the city does not allow residents to have chickens; his neighbor is moving because of this.

Diana Gillan, 5701 Spring Hollow Lane, The Colony – She's lived here 30 years and lives behind Stewart Creek Park. She said the parks are great, Stewart Creek Park is great. The 2009 Master Plan indicates an event center was going to be put in at Stewart Creek Park; the board should remember that families live near parks and to keep sound in mind when planning locations for things.

Michael Hundt, 6413 Stewart Blvd., The Colony – He's lived here 41 years. The trail system is great but would like it to grow faster. He would like to see a large gym built in the city like Frisco has because The Colony is losing teams to other cities, and expand the tennis courts.
